4. FIRST AID MEASURES

EYE CONTACT FIRST AID:

Hold eyelids apart and flush eyes with plenty of water for at least 15 minutes. Get medical attention.

If a person notices any ill effects from breathing vapors, remove from area. Get medical attention.

SAFEGUARDS (PERSONNEL):

Avoid breathing vapor. Wear safety goggles.

INITIAL CONTAINMENT:

Absorb spills with inert material.

SMALL SPILLS PROCEDURE:

Absorb spills with inert material. Neutralize with dilute acid (e.g., vinegar). The neutralized product must be diluted with water before discharge.

Avoid contact with skin and eyes. Avoid breathing vapor.
